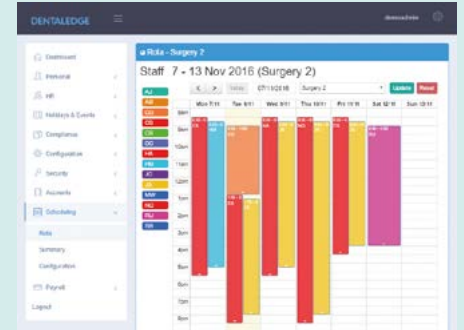

# DentalEdge is a complete dental practice management solution that complements clinical management systems such as Software of Excellence (SoE)

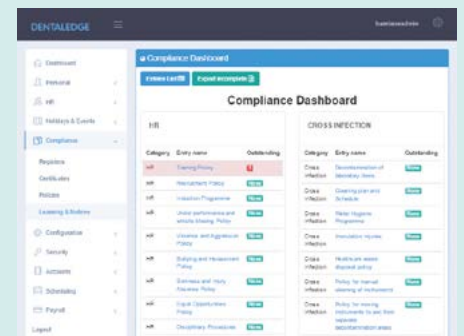
Being a cloud-based application, **DentalEdge** can be easily accessed using tablets, smartphones and of course, Windows and Apple computers.

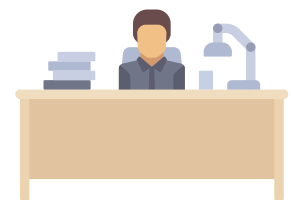
### Savings in temp staff costs

By ensuring that staff rotas are built correctly and controlling when staff holidays are taken, **DentalEdge** delivers savings in the cost of temporary staff.



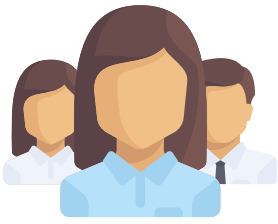
### Compliance

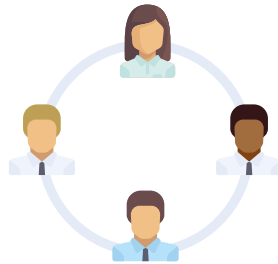
## Compliance

## Payroll

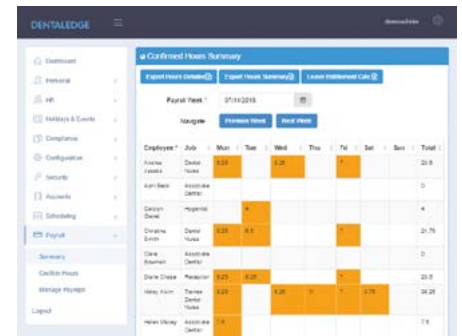
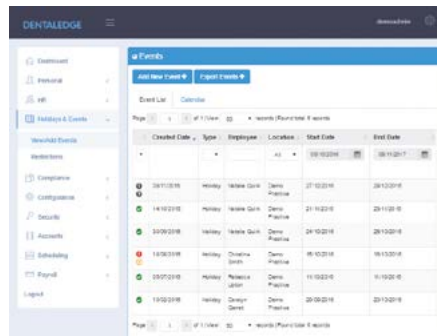
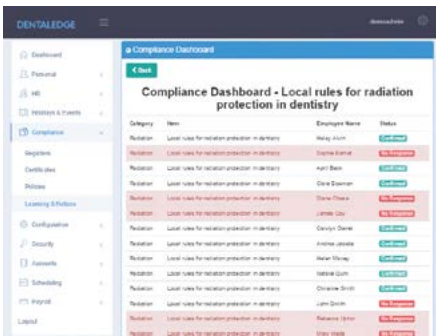
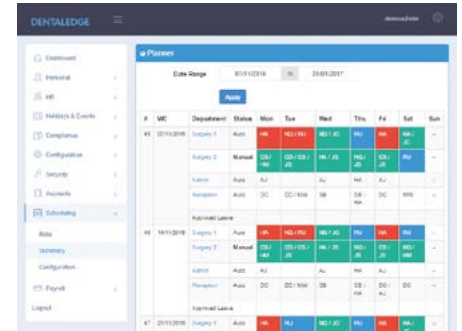
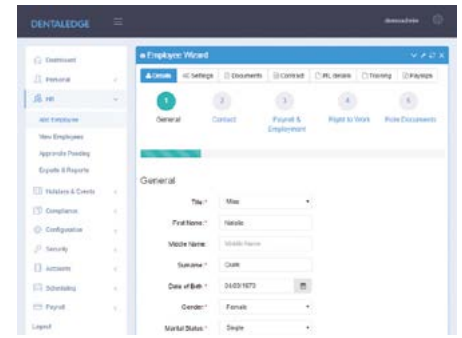

## Accounting
